

Terms & Conditions:

1. Photograph packages cannot be split between two or more people, however group shoots are more than welcome and a total of 4 solo photos are included in group shoots.
2. Group or family shoots with more than five people are subject to higher rates.
3. A non-refundable deposit of 50% and the amount charged for travel fees must be paid a week in advance, unless otherwise specified by Neas & Divi Media in order to confirm and secure your booking.

Upon making this deposit the client is then agreeing to the following conditions:

4. Clients are to make full payment the day before the photo/video shoot or event. Shooting will be postponed to a later date should payment not be made by the designated date.
5. Payment for events (inclusive of weddings) is to be made in full before the day of the event. Should payment fail to be made by the designated date the booking shall be cancelled and deposit forfeited, unless otherwise specified by Neas & Divi Media.
6. If the client cancels or fails to attend their photo/video shoot, their deposit and travel fee will be forfeited. If client's event is cancelled the package can be transferred to another event or the deposit is forfeited.
7. Meals are to be provided for the photographers and videographers at all events (inclusive of weddings).
8. Should guests at the event or wedding like individual photographs taken they are more than welcome to request it after the main event is over and once all official photographs are done. Guest will be billed separately from the client's package unless otherwise specified by the client.
9. If the client for any reason chooses to not take the photographs/video from the shoot, then the client's full payment and travel fee will be forfeited.
10. If the client chooses to postpone their photo/video shoot they have a maximum of 6 weeks in which to claim their shoot before their deposit is forfeited.
11. We are not liable for the loss/damage of client property during shoots.
12. If the client is not at the location of the shoot in the time slot that was booked, the client is allowed a 30 minute gateway in which to get to the location before we continue with the next client or leave the location.
13. Completed photographs/videos are strictly to be collected from 93 Wilkes Road, Sheffield Beach.

14. The unrestricted right and permission forever to copyright and use, re- use, publish, and republish photographic portraits, video footage or pictures of me (the client) or in which I (the client) may be included intact or in part, composite or distorted in character or form, without restriction as to changes or transformations in conjunction with my own or a fictitious name, or reproduction hereof in colour or otherwise, made through any and all media now or hereafter known for illustration, art, promotion, advertising or any other purpose whatsoever, provided that the direct act of Neas & Divi Media does not fall within the lines of pornography or in any way defame the client.
15. The client also gives permit the use of any text material in connection therewith.
16. The client relinquishes any right that they may have to examine or approve the completed product or products or the advertising copy or printed matter that may be used in conjunction therewith or the use to which it may be applied.
17. The client hereby release, discharge and agree to save harmless the Photographer/Videographer (Neas & Divi Media), his/her heirs, legal representatives or assigns, and all persons functioning under his/her permission or authority, or those for whom he/she is functioning, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form whether intentional or otherwise, that may occur or be produced in the taking of said picture or in any subsequent processing thereof, as well as any publication thereof, including without limitation any claims for libel or invasion of privacy.
18. Under no circumstance is the logo of Neas & Divi Media to be removed, cut out or cropped out of an image.
19. All images and video footage produced by Neas & Divi Media will be uploaded on to the social media sites of Neas & Divi Media, unless otherwise specified.
20. Editing of images and video footage produced by Neas & Divi Media is strictly prohibited.

The following terms and conditions apply to extra photos taken by the client:

21. If the client chooses to take extra photographs or extend video coverage the extra photos/video footage will be priced according to the package that the client initially purchased.
22. Should the client choose to take extra photographs /video footage that photo/video footage are to be paid for by latest a week after the shoot/event.
23. Once a client specifies that they would like to purchase extra photographs those photographs go into editing with the initial package that the client has purchased and the client is obligated to pay for all extra photographs once confirmation is made of the extra photos.
24. Clients are obligated to purchase extra video footage once a verbal agreement is made to extend the coverage time.

25. Photographs and Video footage will only be worked on once full payment is made (inclusive of all extra photographs and video footage).

26. No photographs or videos will be released before payment is made in full.

The following are the terms and conditions applied to our specials and promotions:

27. If a deposit is made for a special and the client postpones the shoot, the client may only be granted another slot within the special period if there is an available slot after all other interested client have confirmed their slots. If the client cannot acquire a slot within the specials running period the clients deposit will be valid till the second week into the next month. However the shoot will be under normal photo shoot rates and not those of the special.

28. Special packages do not apply for event photography unless otherwise specified.

Kindly be aware that these terms are subject to negotiation, deletion or addendum, which may be valid if handwritten on this release and initialled and dated by both parties (The Photographer and Undersigned) next to the modification or any modification that is typed and signed by both parties. Modifications may be implied by any releases/contracts with my employer without my notice by the Photographers.
